



TERMS & CONDITIONS

预定条款与细则

- Costa Cruises do not provide advice regarding passports and/or visas. However, all guests are required to carry a passport usually valid for 6 months after disembarking the ship, and any necessary visas. No refund or compensation will be made to guests who are denied embarkation resulting from non-compliance of immigration requirements.
歌诗达邮轮不提供有关护照和签证的建议。所有客人必须自行携带护照以及必备的签证，该护照至少要有六个月或以上有效期为准，对不符合入境要求而被拒绝登船的客人将不获得任何退款或补偿。
- Costa Cruises welcomes pregnant women but will NOT accept guests who will enter the 24th week of pregnancy by the beginning of the cruise.
歌诗达邮轮欢迎孕妇参加配套，但不接受在游轮出发前进入怀孕第24周的孕妇。
- Children under the age of 18 may not travel unaccompanied on board our ship. Babies will not be permitted to board if they are less than 6 months old on the first day of the cruise.
18岁以下没有家长陪同不被允许上船。如果婴儿在巡航的第一天不到六个月，也不能登船。
- All guests are strictly prohibited from bringing alcohol and/ or alcoholic drink onboard the ship.

- Change Name / 更换乘客名字 **RM 200** per person no latest than 30days prior to cruise ******(Must remain one original passenger in same cabin) (必须保留一位原先乘客在同一间房)**
- Full payment must be made upon booking. 在预订时必须支付全额费用。
- For travel fair or special promotion **STRICTLY NO** changes on name or sailing date / itinerary will be allowed.
在任何旅游展或促销优惠购买该配套者，将不被允许做任何名字、出发日期和行程上的更改。
- Cancellation fees above are applicable for low and mid season only. For peak season or Special discount promotion, 100% cancellation fees apply. 以上取消费用只适用于淡或旺季而已。超旺季或特价优惠配套于 100%取消费用为准。
- Apart from the above cancellation fee stated under the terms and conditions of the respective third parties (cruise principle), you are liable to be charge an **administration fee of RM100.00** per service per person irrespective of circumstances.

- A **6% foreign exchange conversion fee** will be imposed as cruise fare affected by foreign exchange currency

- Non cruise component such as coach transfer, flight, insurance & etc. are strictly non-refundable.

- All cancellation will be imposed with **RM 105.00 per person for refund administration charge**.

- All the above will be subjected to change without prior notice. 所有以上资料如有更改，恕不另行通知。
- Costa Cruise reserves the right to cancel substitute any schedule port call / itinerary / price / program / vessel/ cabin at any time without prior notice.
