

TERMS & CONDITIONS 预定条款与细则

IMPORTANT NOTICE 重要提示:

- Guest is responsible to ensure that all travel documents, visas and other immigration requirements which may include but not limited to the following applicable examples; 客户有责任确保所有旅行证件,签证及其他入境规定(其中包括但不限于以下适用的实例;
 - Original photo ID/driver's license, birth certificates for child below 12 years old. 原始照片的身份证/驾驶证,出生证明为 12 岁以下儿童
 - Passport validity of <u>at least 6 months</u> is in order and complied with prior to departure from their home country. 护照至少 6 个月有效期是为了与之前从各自的国家出境的船客遵守
- No refund or compensation will be made to guests who are denied embarkation resulting from non-compliance of immigration requirements. 拒绝登船的客人将不被退款或做出任何相关赔偿.
- Passenger for a <u>pregnant woman</u> will only be permitted <u>before her 22nd week of pregnancy</u> & infant above 6months at the time of sailing. 怀孕乘客于出航日期其怀孕周期不超过 22 周者以及 6 个月以上的婴儿方被允许登轮航游.
- For cruises that depart a port in Europe, Asia, South America, New Zealand, or Australia, the nominated accompanying adult must be 18 years and above. For all other countries for cruise departures, the adult must be 21 years and above. A CONSENT Form need to be fill for minor (0-17) child to travel without parent/legal guardian. 对于从欧洲、亚洲、南美洲、新西兰或澳大利亚港口出发的游轮,指定的陪同成人必须年满 18 岁。对于其他国家的邮轮出发地,成人必须年满 21 岁。 未成年人(0-17 岁)在没有父母/法定监护人陪同的情况下旅行,需要填写一份同意书携带登船。
- ▲ All guests are strictly prohibited from bringing alcohol and/ or alcoholic drink on-board the ship. 所有船客都严格禁止携带含有酒精之饮料上船.

FINAL PAYMENT TERM 最终付款期限:

- It is the guest responsibility to monitor the final payment deadline and arrange the necessary payment by contacting us on or before the final payment date associated with the booking. 客户有责任监督最终付款期限,并在与预订相关的最后付款日期之前与我们联系,安排必要的付款。
- If no call was received form the guest to provide further payment instruction, booking will be automatically cancelled with penalty. There will be no reminder in the form of calls or emails. 如果没有收到客人任何电话提供进一步的付款指示,预订将被自动取消,并予以处罚。将不会有电话或电子邮件的形式提醒。

CANCELLATION FEES POLICY 取消费用政策:

- Cancellation fees stated above are applicable for low and mid-season only. For peak season, 100% cancellation fees apply. 以上取消费用只适用于淡或旺季而已。超旺季于 100%取消费用为准。
- Amendment of reservation is considered a cancellation and the necessary fees as per below will still apply on top of the new fare. 修改预定日期将被视为是取消,必要按上述费用以及按现行税率计算新的航程价钱。
- Apart from the above cancellation fee stated under the terms and conditions of the respective third parties (cruise principle), you are liable to be charge an administration fee of RM100.00 per service per person irrespective of circumstances.
